MOTM will automatically take 15% processing fee from the selling price before adding shipping charges. You will decide the shipping charges for your product in our store. MOTM will charge the clients Credit Card (or receive check) and pass on the net amount, via check payment to the seller to fulfill once it is processed. The Seller will receive an email with all the pertinent information so the seller can then fulfill the order in a timely manner of not more than 10 days unless advised to the client and MOTM.

You will receive payment for the product no more than 10 working days from time the client is charged for your product.

Mom Shop descriptions will not contain website addresses but you can refer clients to your Mom ad on our website if you choose to purchase a Mom Ad.

The selling price on the MOTM site cannot be more than the usual selling price of the product/service on your own website.

1. MOTM will allow Seller to promote specified product (as listed in Appendix A) on www.momsonthemove.com Mom Shop for sale.
2. Seller agrees to pay MOTM a commission equal to% of advertised selling price for all items sold via the site.
3. MOTM will advertise the specified product on the Mom Shop for a period of 3 months, from the date of this contract and then have the right to remove item from the Mom Shop if sales fall below 10 items in that period.
4. MOTM can continue the advertising of this product after the initial 3 month period at their discretion under the Terms of this Contract.
5. MOTM have the right to refuse items to be advertised at their discretion.
6. Upon an order being made by a buyer through the website, MOTM will charge the buyers credit card or receive payment via check/money order and then pass the net amount (sale price less agreed upon commission plus shipping and handling) to the seller via check upon cleared funds being available.
7. Seller will, upon receipt of the funds from MOTM, fulfill the buyers order within 10 days or receipt of the order. A confirmation of the completion of the order, showing shipping details and date must be sent via email to orders@momsonthemove.com at that time.
8. Seller is responsible to ship the order in accordance to the buyer's requests to the specified buyers address as supplied by MOTM.
9. Seller at all times is responsible for the products being sold and MOTM has no liability for defective products.
10. Seller must replace a defective product within 20 days of receipt of defective goods being returned to the seller.
